APPLICATION GUIDELINES

For Applicants Requesting to be Admitted as Regular Members of the Association des Acadiens-Métis Souriquois (AAMS)

1. LONG FORM BIRTH CERTIFICATE OR BAPTISMAL CERTIFICATE

Certificates are required to certify your connection and your parent(s) connection to your genealogical references. Your genealogy should be obtained first to determine what certificates are needed. Baptismal certificates can be obtained cheaply from the church parish where you and your parent(s) were baptized.

If baptismal certificates are not available, you can apply for **Long Form** birth certificates from Vital Statistics, PO Box 157, Halifax, N. S., B3J 2M9; Ph (toll free) 1-877-848-2578, Fax (902) 424-4143, E-mail: <u>vstat@gov.ns.ca</u> Application forms can be printed out from Service Nova Scotia, Vital Statistics at: <u>www.accessns.ca</u> or you can apply on line.
